Please take a moment to read the following policy to learn how they handle your personal information.

Why ORANGE AFFAIRS and its brands collect personal information:

ORANGE AFFAIRS and its brands collect and use your personal information to give you superior customer service, to provide you with convenient access to their products and services, and to make a wider range available to you. In addition, ORANGE AFFAIRS and its brands use your personal information to keep you up-to-date on the latest product announcements, updates, special offers, and other information they think you would like to hear about. This may occasionally include information from other companies about products and services that can add value. From time to time, ORANGE AFFAIRS and its brands may also use your personal information to contact you to participate in a market research survey, so that they can gauge customer satisfaction and develop better products and services.

How ORANGE AFFAIRS and its brands collect personal information:
